Prepare for Fall In-training Exams

With the Fall 2022 ABFAS In-training Examinations (ITEs) coming up, you may be wondering about the best way to prepare. ABFAS recently augmented the material available on the practice Didactic examination and practice NEW CBPS examination, which will help orient you to how the exams work and what sorts of questions are included. The ABFAS website offers four Didactic practice exams, two for Foot Surgery and two for Reconstructive Rearfoot/Ankle (RRA) Surgery. ABFAS recently increased the number of practice questions offered, from 25 to 30 questions per exam. You can also review the ABFAS website for information on ITE content and scoring.

The 2022 PGY1&2 (and 3 in 4-year programs) exams take place September 19-24, and the 2022 Final-year ITEs are on October 11-12. Residents do not need to register for ITEs as their Residency Directors will register them. However, residents must schedule their own exams.
