Recertification: Uploading Case Logs

The 2019 Recertification (MOC) exam registration is now open and closes on January 18, 2019. Diplomates may take their examination in the eighth, ninth, or tenth year of their MOC cycle. In order to register for the MOC, you need to submit your case logs from all hospitals and/or surgery centers from the past two years. There are no minimum case volume or diversity requirements. Your case logs will help ABFAS redesign our recertification process in the future.

To submit your case logs:

- Your hospital or surgery center should provide your case log history.
- Contact all hospitals and/or surgery centers where you perform surgery and ask them to print out your case logs from the past two years.
- Save your entire two-year case log history into a single PDF before you start the registration process.
- Please make sure your case logs include the type of case, which could be shown by CPT code and/or procedure.

When starting to register for the exam, you will see instructions on how to upload your single PDF case log history onto the ABFAS website.
